Domestic Violence, Sexual Violence & Stalking: A Workshop

On Tuesday, November 19, the Office of Human Resources will partner with Womanspace to host a workshop on domestic violence, sexual violence and stalking.

Domestic violence and sexual assault have much in common. Both are about power and control, humiliation and dominance. The need to address prevention of domestic violence and sexual assault is not just a women's issue, and it is not just an individual or family problem. Violence against women is a human issue and social problem. It's up to the community to take a stand against abuse, hold abusers accountable for their behavior and protect victims.

Womanspace is the only agency with staff specifically trained to assist victims of domestic violence and sexual assault in Mercer County, New Jersey. Clients come from every geographic, socio-economic, cultural, racial, sexual orientation and religious background and present a diversity of needs – from the emergency need for safety to the long-term need for housing.
